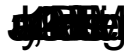

The North Newton School Corporation Board of School Trustees held their regularly scheduled meeting on Monday, January 14, 2019 at 6:00 p.m. at the Corporation Office Board Room.

The Board of School Trustees opened the meeting with the organization of the Governing Body with the following Board elections: Board President-Michael Russell, Board Vice President-Paul Sheldon, Board Secretary-Patricia Reyes, then followed with approval of appointments of Corporation Treasurer, Deputy Treasurer, Corporation Attorney, Bid Opening Committee, Policy Liaison Committee, Recording Secretary, and Assistant Recording Secretary.

The Board of School Trustees welcomed new Board Members John Haas and Kevin Rainford; recognized Emilie Tsorvas, 7<sup>th</sup> Grade at the Jr.-Sr. High, as January Student Spotlight and Holly Midkiff, Secretary/Treasurer at Lincoln Elementary, as January Employee Spotlight.

The Board of School Trustees approved: consent agenda items of: 12-10-18 Board Minutes, donations, field trip requests, financial claims and reports, and personnel reports; the following Resolutions to Establish Board of Finance for 2019, Transfer Appropriations, Transfer Funds to Rainy Day Fund, Authorized One-Time Transfer of Funds from the Cash Balance of the Education Fund to the Cash Balance of the Operations Fund, and Transfer Amounts from the Education Fund to the Operations Fund; five Conflict of Interest Disclosure Statements for Board Members; and to dispose of Obsolete Textbooks at Lincoln Elementary, through an attempt to sell them then donate to a named organization if not able to sell.

North Newton School Corporation is pleased to thank our donors within our school community.
